Notification

It is notified that the competent authority has approved the option of online examinations for students of terminal semester / year for courses being run in UTDs and affiliated colleges (except education colleges) with following conditions:

- 1. The offline examinations will commence from 1/09/2020, as already notified.
- 2. The online examinations may be commenced after about 20 days from commencement of offline examinations for above courses.
- 3. The student can opt only one option, either offline or online.
- 4. The student can choose the online mode by sending email at onlineconduct@crsu.ac.in by 5/09/2020 by sending the duly filled Performa at page 3 as an attachment.
- 5. The online examinations may be conducted with live monitoring and video recording and may be based on MCQs, subjective type (through scanning & uploading or typing) or mixed type questions. However questions may be of conceptual type such that solution of questions could not be found in books directly.
- 6. The students opting online mode will have to arrange hardware of required specifications (Desktop / Laptop / Mobile with good camera) and high speed internet on its own and is to undertake that he / she will be responsible for functioning of hardware and internet. No claim will be considered for malfunctioning of hardware / failure of internet or uploaded blurred (Non Readable) images.
- 7. The student will not be allowed to leave his /her position in front of camera during tenure of examination (except during scanning). Any movement or doubt full activity may be considered as Unfair Mean Case. (All movements will be recorded and monitored with AI enabled system).
- 8. The result of online mode for above courses may be delayed for few days as that of offline mode.
